November 2024 Central Government Budget

In November 2024, central government budget expenditures were recorded as 956.1 billion TRY while budget revenues were 939.5 billion TRY and budget deficit was 16.6 billion TRY. On the other hand non-interest budget expenditures amounted to 809.8 billion TRY and primary surplus amounted to 129.7 billion TRY.

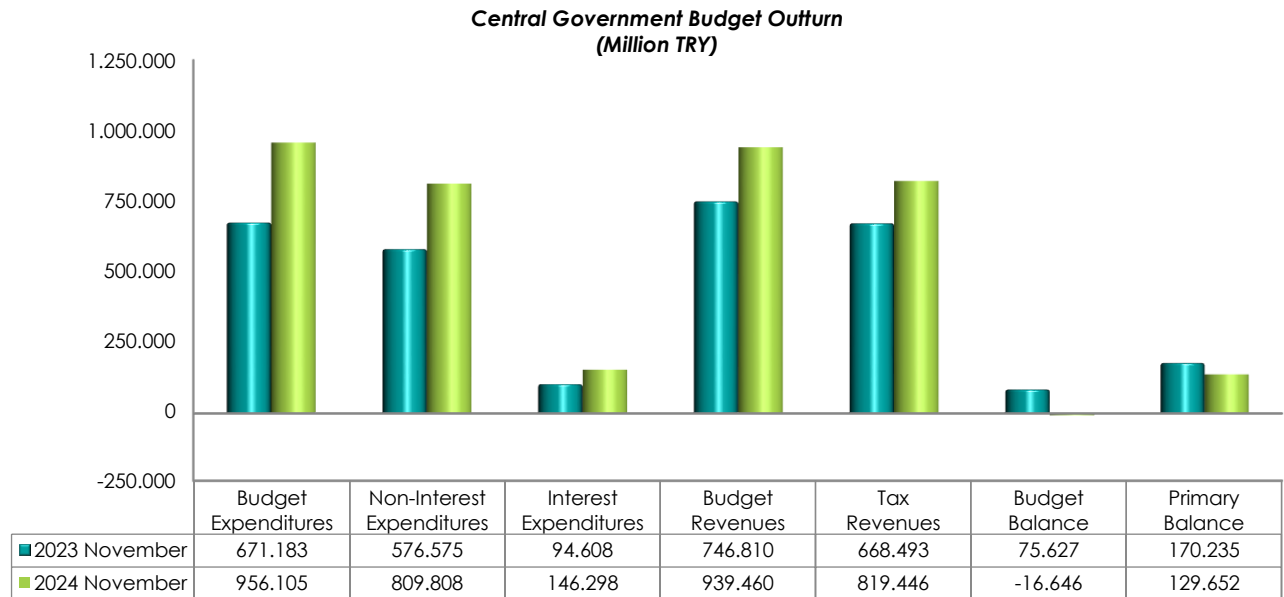

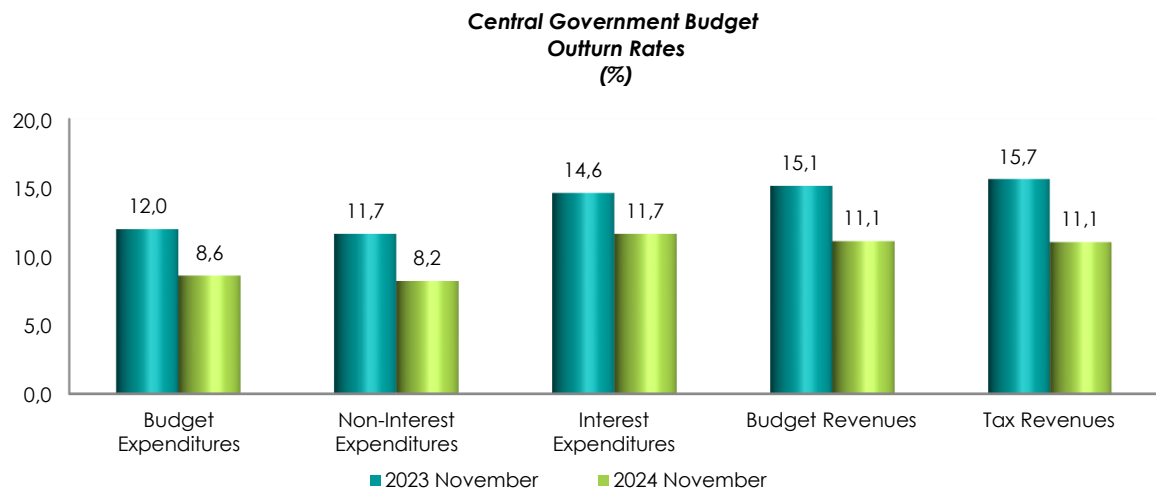

In November 2024, central government budget recorded a deficit of 16 billion 646 million TRY while it recorded a surplus of 75 billion 627 million TRY in the same period of the previous year.

In November 2024, primary surplus was recorded as 129 billion 652 million TRY while it was 170 billion 235 million TRY in the same period of the previous year.



The outturn rates of November figures compared to budget allowances are given in the graphic below.



2- Budget Expenditures

In November 2024, central government budget expenditures were recorded as 956 billion 105 million TRY. Interest expenditures amounted to 146 billion 298 million TRY while non-interest expenditures amounted to 809 billion 808 million TRY.

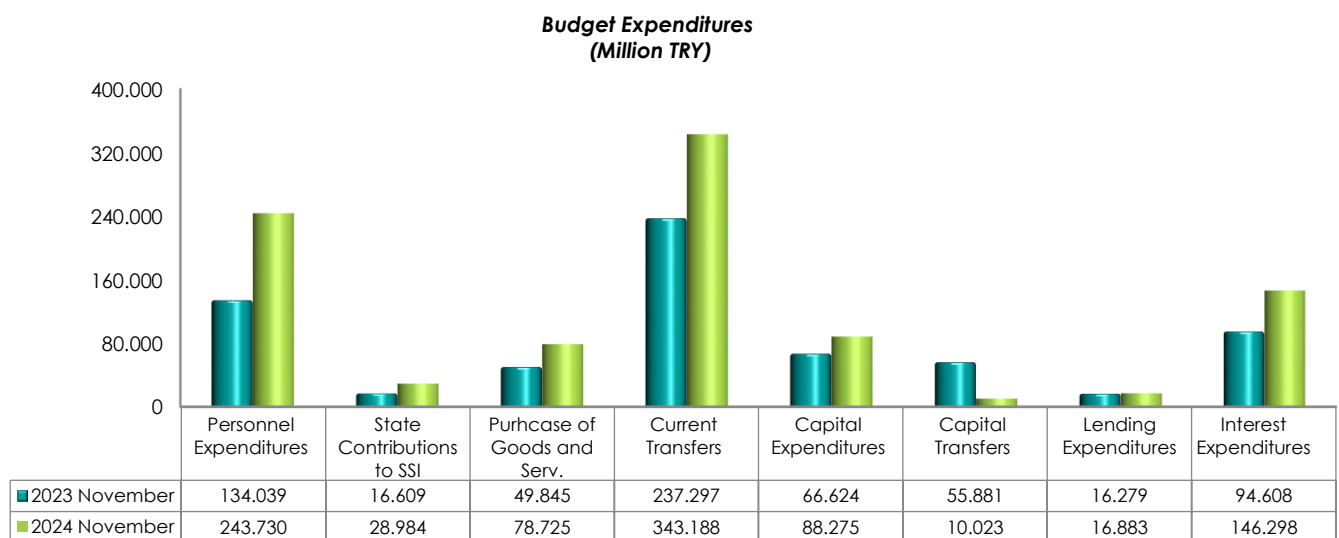

In November 2024, 956 billion 105 million TRY was spent from the appropriation for 2024 central government budget expenditures allocated as 11 trillion 89 billion 37 million TRY. The expenditure was 671 billion 183 million TRY on a year-on-year basis.

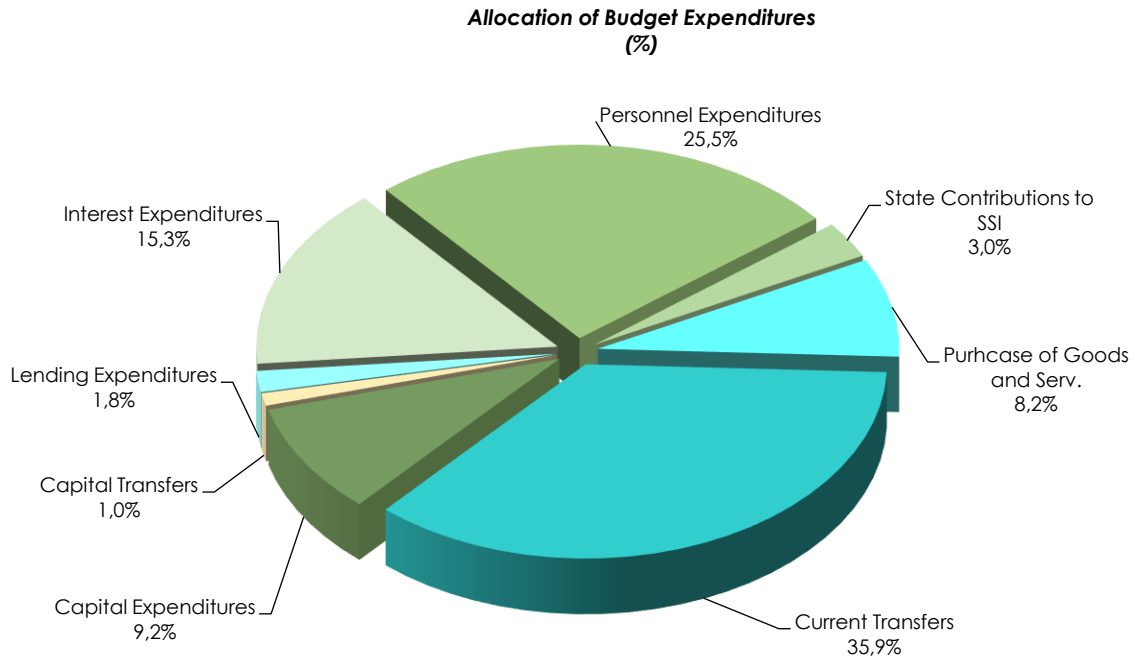
November budget expenditures increased by 42.5 percent on a year on year basis. The outturn rates of the expenditures compared to budget appropriations are 12 and 8.6 for 2023 and 2024, respectively.

Non-interest budget expenditures amounted to 809 billion 808 million TRY increasing by 40.5 percent compared to the same month of the previous year. The outturn rate of the non-interest budget expenditures compared to budget appropriations was recorded as 8.2 percent in 2024 while it was 11.7 percent in 2023.

3- Budget Revenues

In November 2024, central government budget revenues were recorded as 939 billion 460 million TRY. Tax revenues amounted to 819 billion 446 million TRY while general budget non-tax revenues amounted to 97 billion 701 million TRY.

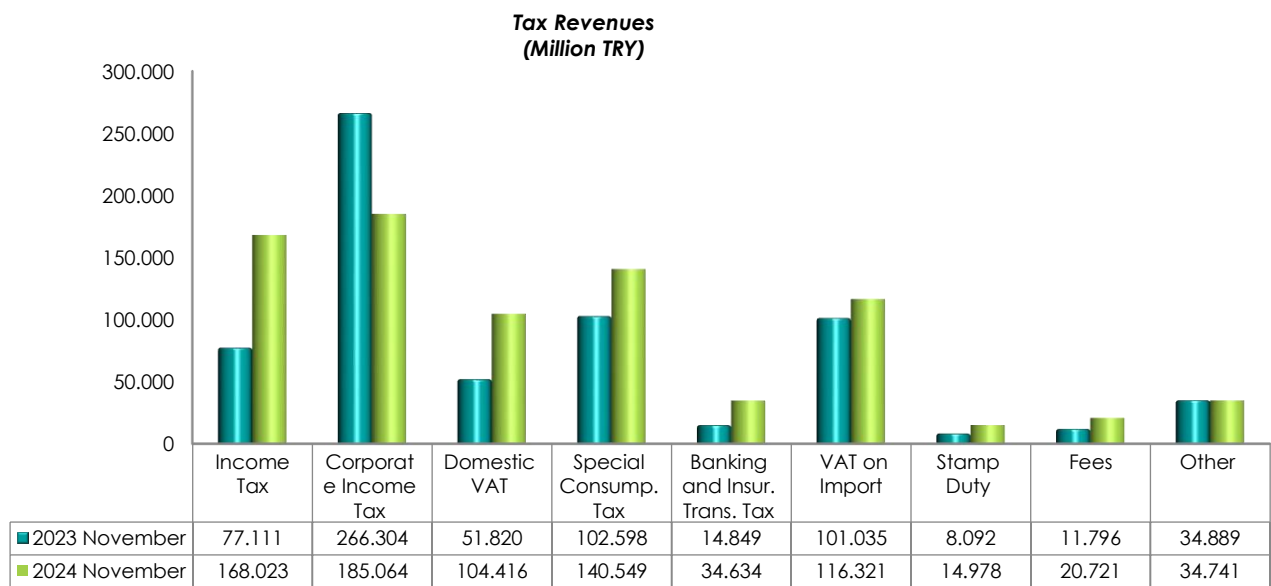

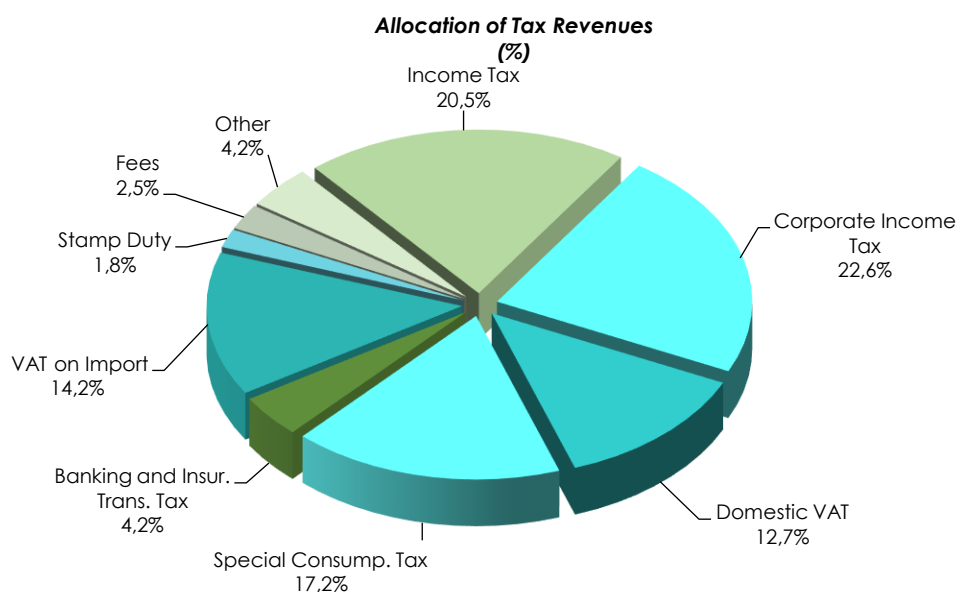
In November 2024, budget revenues were recorded as 939 billion 460 million TRY, increasing by 25.8 percent from the budget revenues of 746 billion 810 million TRY in November 2023. The outturn rate of November budget revenues compared to budget estimates was recorded as 11.1 percent in 2024 while it was 15.1 percent in 2023.

November 2024 tax collections were recorded as 819 billion 446 million TRY, increasing by 22.6 percent compared to the same month of the previous year. The outturn rate of November tax revenues compared to budget estimates was recorded as 11.1 percent in 2024 while it was 15.7 percent in 2023.

November tax revenues compared to the previous year figures are given in the graphic below.

January-November 2024 Central Government Budget

In January-November 2024, central government budget expenditures were recorded as 9 trillion 70.2 billion TRY while budget revenues were 7 trillion 793,3 billion TRY and budget deficit was 1 trillion 276.9 billion TRY. On the other hand non-interest budget expenditures amounted to 7 trillion 875 billion TRY and primary deficit amounted to 81.7 billion TRY.

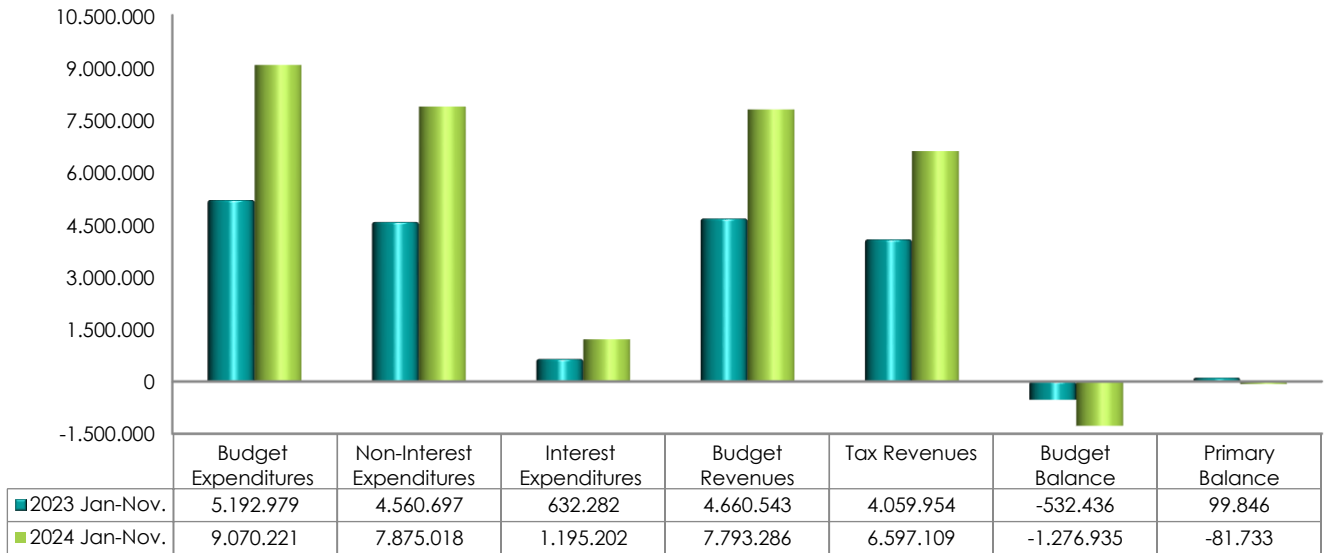

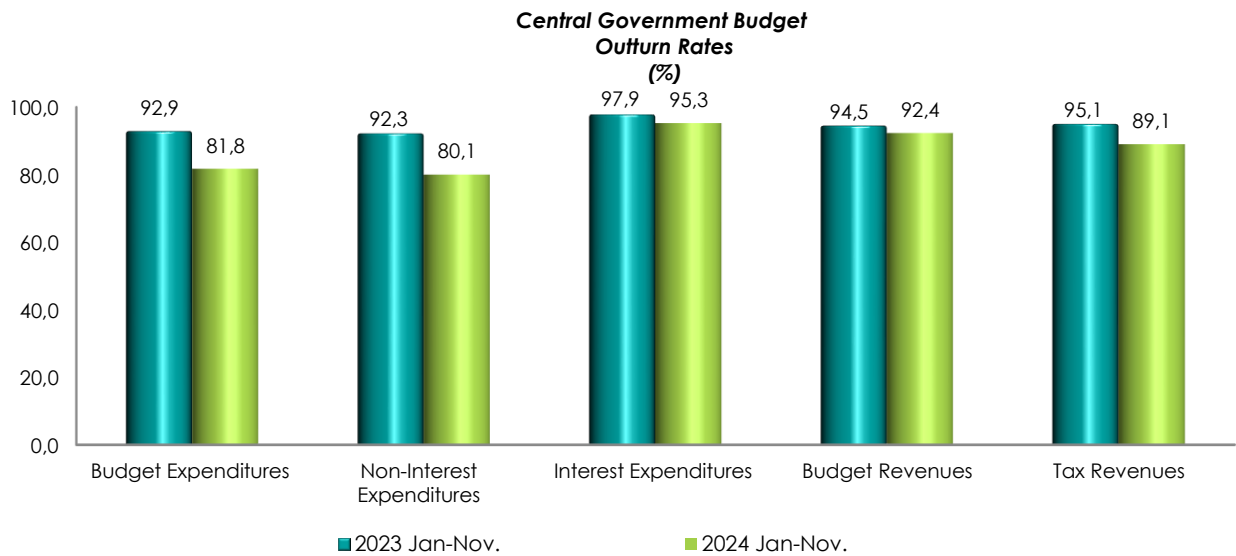
In January-November 2024, central government budget had 1 trillion 276 billion 935 million TRY deficit while it was 532 billion 436 million TRY in the same period of the previous year.

In January-November 2024, 81 billion 733 million TRY primary deficit was recorded while 99 billion 846 million TRY primary surplus was recorded in the same period of the previous year.

2- Budget Expenditures

In January-November 2024, central government budget expenditures were recorded as 9 trillion 70 billion 221 million TRY. Interest expenditures amounted to 1 trillion 195 billion 202 million TRY while non-interest expenditures amounted to 7 trillion 875 billion 18 million TRY.

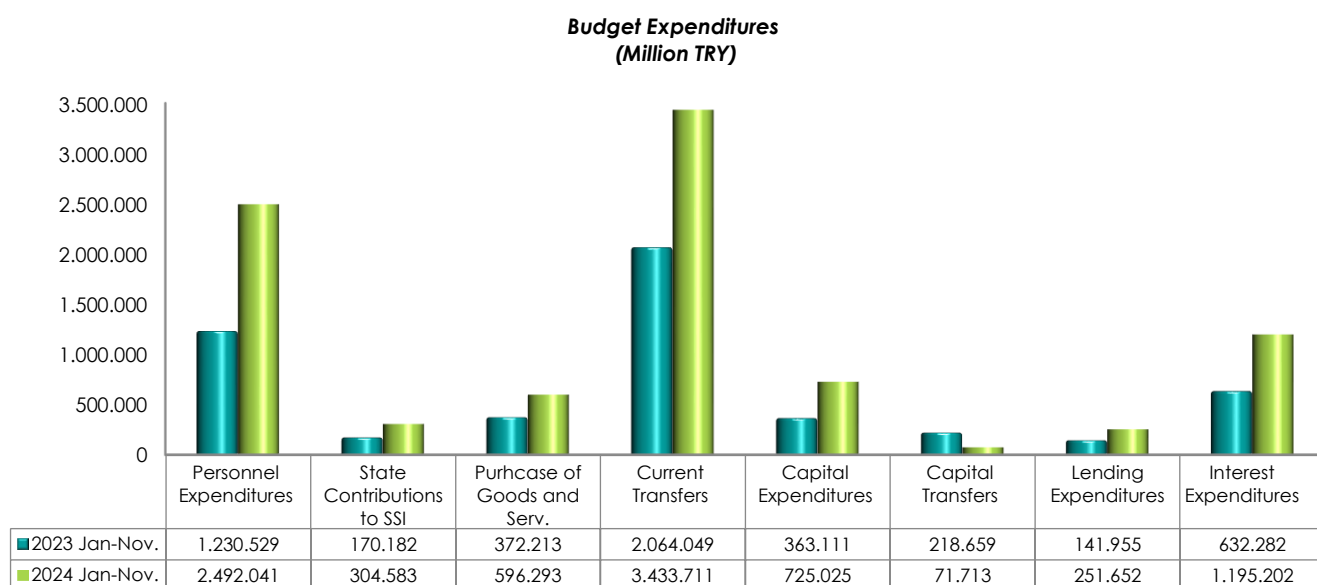

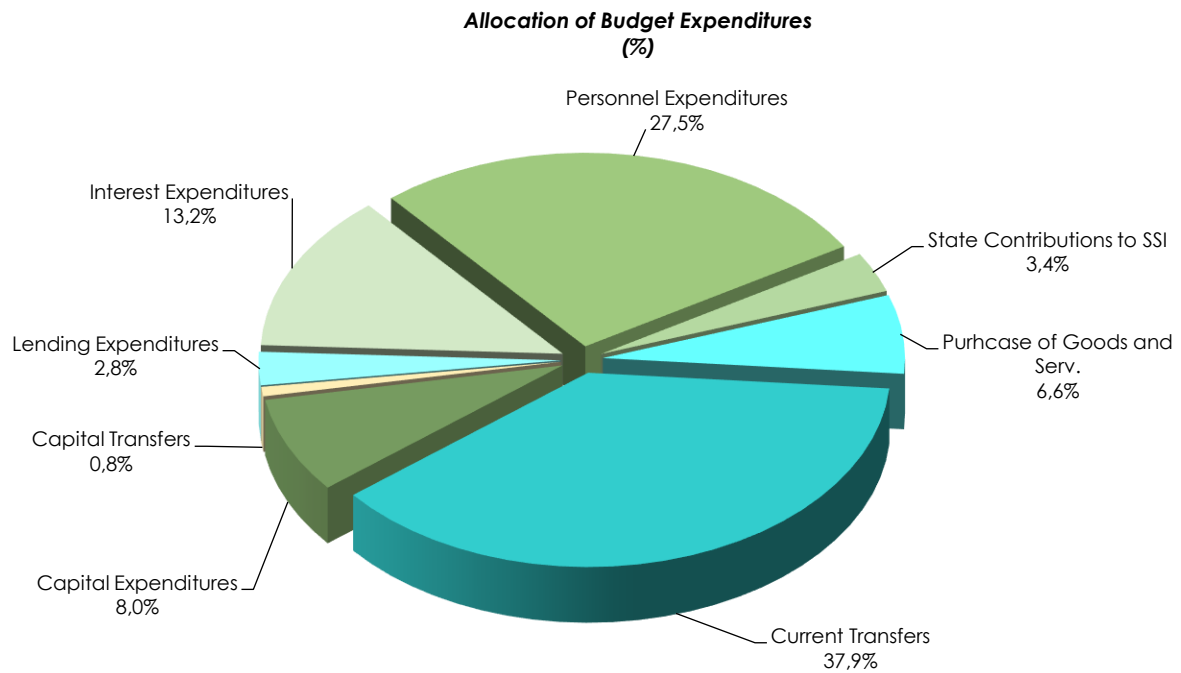
In January-November 2024, central government budget expenditures were recorded as 9 trillion 70 billion 221 million TRY increasing by 74.7 percent compared to the same period of the previous year.

Non-interest budget expenditures amounted to 7 trillion 875 billion 18 million TRY increasing by 72.7 percent compared to the same period of the previous year.

January-November budget expenditures compared to the previous year figures based on the economic classification are given in the graphic below.

3- Budget Revenues

In January-November 2024, central government budget revenues were recorded as 7 trillion 793 billion 286 million TRY. Tax revenues amounted to 6 trillion 597 billion 109 million TRY while general budget non-tax revenues amounted to 997 billion 578 million TRY.

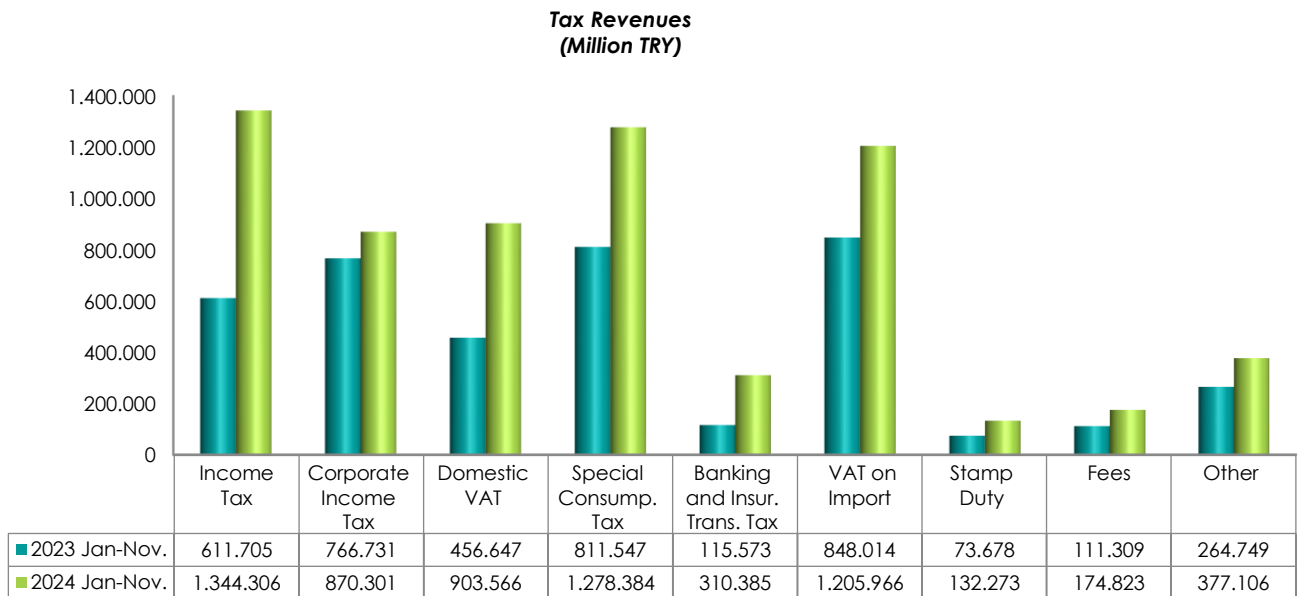

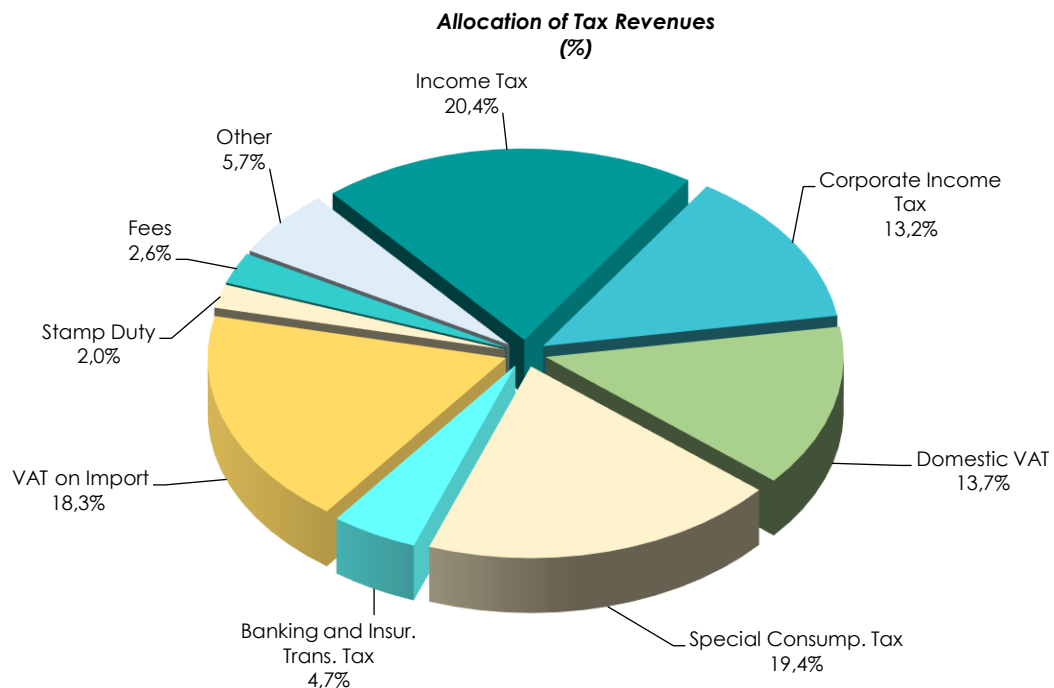
In January-November 2024, budget revenues were recorded as 7 trillion 793 billion 286 million TRY, increasing by 67.2 percent from the budget revenues of 4 trillion 660 billion 543 million TRY in January-November 2023.

January-November 2024 tax collections were recorded as 6 trillion 597 billion 109 million TRY, increasing by 62.5 percent compared to the same period of the previous year.

January-November tax revenues compared to the previous year figures are given in the graphic below.

DEFINITIONS

Budget: refers to the document which indicates the revenue and expenditure estimations of a certain period and issues related to their implementation, and which is put into effect as required by the relevant procedures,

Budget Balance: refers to the difference between budget expenditures paid by public administrations in cash or on account, pursuant to the spending authority (appropriation) stated in the budget and collected budget revenues,

Budget Revenues: refers to taxes, levies, charges, holding funds, shares or similar revenues acquired pursuant to their respective laws, revenues from interests, surcharges and fines, all types of revenues acquired from movable and fixed assets, revenues obtained from services rendered, revenues from premium-sold borrowing instruments, deductions from social security premiums, donations and grants received, and other revenues.

Budget Expenditures: refers to budget expenditures consisting of payments for the goods and services acquired and for the works done pursuant to their respective laws, social security contributions, interest payments of domestic and foreign debts, general borrowing expenditures, payments resulting from the discounted sale of borrowing instruments, economic, financial and social transfers, donations and grants, and other expenditures,

Current Transfers: refers to the unrequited payments that do not target capital formation and are made to finance current purchases of goods and services,

Regulatory and Supervisory Agency Budget: refers to the budget of each regulatory and supervisory agency, which is included in chart III of the Law No. 5018 and established in the form of board, agency or supreme board by special laws.

Primary Balance: refers to the balance found by subtracting non-interest budget expenditures from total budget revenues.

General Budget: refers to the budgets of public administrations, which are included in chart (I) of the Law No. 5018 and which are under the legal entity of the government,

Central Government Budget: refers to the budgets of public administrations included in chart (I), chart (II) and chart (III) of Public Financial Management and Control Law No. 5018.

Capital Expenditures: refers to the purchase of goods and services exceeding the minimum value determined by the budget laws and have a useful life of more than one year.

Capital Transfers: refers to the grants given to persons and institutions with the purpose of financing capital expenditures such as buildings and other construction works, transportation vehicles, machineries and fixtures.

Special Budget: refers to the budget of each public administration, which is included in chart (II) of the Law No. 5018 and established as affiliated or related to a ministry for carrying out of a defined public service, to which revenues are allocated, and which are authorized to spend from such revenues, whose establishment and operation principles arranged through special law.

Own-Revenue: refers to the revenue items which are generated as a result of administration's activity and not transferred from another unit within the scope of the central government.



Central Government Monthly Budget Report is published monthly by the Ministry of Treasury and Finance, Directorate General of Public Financial Management and Transformation.
